Markham's Backflow Prevention Program for water supply system has **three requirements:**

- (1) Test all testable backflow devices and submit their "Test" Reports every year.
- (1) Assess all "Cross Connection Controls" in private water systems and submit a "Survey" Report every 5 years.
- (2) Complete all "Device Upgrades" as required by the "Survey" Report and submit a "Device Upgrades" Report.

You (as the property owner) are required to hire a "Qualified Person", at your own expense, to complete the following work and submit related Reports to the City's Online System **by **xxx, 20xx****

Test: Your testable backflow devices in City records are listed in the attached. If "Test Due" date was due or will be due by Dec 31, 20xx, complete their Tests. [Note: If other testable devices are found at the facility but not on the List, complete their Tests as well].

Survey: Your next Cross Connection Control Survey is due on Dec 31, 20xx. If next Survey is blank, was due or will be due in 2024, complete a new Survey along with the Test work.

Device Upgrades: Your last Cross Connection Control Survey was completed on Dec 31, 20xx. If the attached "List of Device Upgrades" required by last Survey is not blank, complete all "Device Upgrades" work (i.e. install, repair or replace backflow devices).

Notes:

- (1) If the "Device Upgrade" is for **fire system**, you can install it when your fire system has a major upgrade.
- (2) If the "Device Upgrade" is to install/replace a testable device (i.e. RP, DCVA, PVB or SRPVB), **a Permit is required.**
 - a) The Permit can be obtained from our Building Department's online ePLAN system (see link below).
 - a) The Fees are \$321 for first device and \$107 for each additional device.
 - b) Once the work is completed, call our Building Department to get inspection and close the Permit.
